

(a) The SETTLOR is desirous of establishing a TRUST FUND for public charitable objects for general public.


(b) The Trustees have at the request of said SETTLOR agreed to act as Life Trustees.

- 3. The head office of the TRUST FUND shall be at Vill. & P.O. Sikri Ralan, Teh. Modinagar, Distt. Ghaziabad (U.P.) or at such other place or places in India as the trustees may from time to time think fit.
